Executive Board positions are for a one-year term, meaning every position is open for the 2024-25 school year. Note that in addition to the existing Board positions listed on our letterhead, two new positions- Capital Projects Chairperson(s) and Grants Committee Chairperson(s)- will be represented on the Board next year, subject to the PTA General Body approval at the May PTA meeting. ## **NOMINATION PROCESS**

Nominations for the PTA are now open and will close promptly at 7:15 PM on election night scheduled to be held virtually on May 15<sup>th</sup>. Nominations should be emailed to <u>elections@ps11bk.org</u>. A candidate can self-nominate. Nominations can also be made from the floor on the night of the election. The only qualification for all offices is that the candidate be a parent or legal guardian of a child enrolled at the school.
